AUMA India's Solar Power Plant: An Epitome of Energy Efficiency & Power Management system

AUMA India has become the first company in the whole of Peenya which comprises of more than 10,000 industries to export surplus power to BESCOM Grid with the self generation capacity for captive consumption of solar power.


With the total commissioned capacity of 375 kWp of solar power generation from the solar roof top project, AUMA India is the first industry in Peenya, the largest industrial area of South Asia to become an Energy Efficient Leader in achieving the goal of reducing dependency on fossil fuel based energy sources.

AUMA India serves as an epitome of energy efficiency and power management with the overall reduction of 442 tonnes of carbon emissions per year. Now, AUMA India's 50% of overall power requirement had been satisfied from clean energy generated by solar power plant following the model of "Self generation for Grid Connected (Net Metered) Captive consumption".



AUMA India's Net-metering System with BESCOM Grid Export Facility

AUMA India has installed a net metering system to export the surplus power generated especially during weekly offs and holidays to BESOM grid. As of March 2016, AUMA India has exported 24082 units in total to BESCOM since November 2015.
